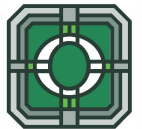

### "Shop Orland Park" Gift Card Program Terms & Conditions

- The promotion is open to both residents and non-residents.
- Visa® gift cards are available on a first-come, first-serve basis, while funds are available.
- Only one application can be submitted for a specific sales transaction. In order to claim the gift card, the shopper must mail the postmarked sales receipt along with a completed rebate form to the Village of Orland Park, 14700 Ravinia Avenue, Orland Park, IL 60462, by August 31, 2020.
- Purchases must be made at businesses within the Village limits of the Village of Orland Park between July 6, 2020 and August 2, 2020. If you are not sure if the establishment is in the corporate limits of the Village of Orland Park, please visit ShopOP.org.
- Limit one gift card per adult.
- Applicants must provide copies of the entire sales receipts. The Village cannot accept partial receipts. Receipts must include: 1) store name and location, 2) all of the items purchased, and 3) date of purchase.

- The Village of Orland Park is not responsible for incomplete forms or late, lost, illegible, stolen, delayed, un-postmarked, postage due, or misdirected mail.
- Complete applications are those that include copies of sales receipts totaling either \$300-\$499, or \$500 or more (including sales tax) and a completed application form.
- Receipts submitted for one application cannot be used for subsequent applications. Large purchases cannot be used for multiple applications. Receipts used as a part of the Orland Park Vehicle Incentive Program cannot be used for this Shop Orland Park program
- Please wait 6-8 weeks for gift card processing.
- Eligible purchases are those items for which sales taxes are collected. Generally, tax is collected on the sales of tangible personal property for use or consumption. Receipts for labor or professional services, tips and the purchase of gift cards/certificates, pharmaceutical prescriptions, and co-pays, are ineligible. The amount of sales tax must be listed on the receipts.
